PRESIDENTS REPORT

In presenting my fifth annual report I would very much like to express my extreme thanks and congratulations to all clubs and individual members of the southern Tasmanian bowls community for the respectful manner in which all have accepted and adhered to the restrictions that have been placed on us all in recent times.

The Coronavirus pandemic caused a complete abandonment of the 2019-20 Bowls Tasmania South (BTS) pennant season on 17 March 2020, with all three pennants being declared concluded at that time, meaning that the Midweek and Saturday pennant competitions ended at the completion of the seventeenth round of the roster season, and the finals series for Women's Thursday Pennant unable to commence. As a result of this decision, the side at the head of the table for each of the pennant competitions was declared the winner of the pennant for that division. This was not a satisfactory outcome for all clubs but the only possible manner in which to bring the 2019-20 BTS Pennant season to a conclusion.

At the time of writing this report decisions have been made in regard to the gradual easing of restrictions on social gatherings, and Bowls Australia has announced its proposed restructure of the Nationals, with Open, Senior and Multiple Disabilities sides competitions removed from the program. Bowls Australia still intends to conduct its Open Men's and Women's Champion of Champions Singles events, probably in December 2020, because of the need to have national representatives for entry into the World Bowls events. Therefore, BTS will be rescheduling its 2019-20 Champion of Champions Singles events when it is known when Bowls Tasmania will be conducting its qualifying event.

The sudden end to the 2019-20 pennant season meant that our first experience of the season extending into April, with Bowls Tasmania's State Pennant Finals to be conducted by the weekend prior to Anzac Day, did not occur, although there were already concerns at BTS Board level as to the availability of sufficient natural grass greens of adequate quality to not only conduct the finals series for each of the three BTS pennant competitions, but also to support BTS' requirement to host Bowls Tasmania's Thursday State Pennant Finals series. The fact that the bowls season in Tasmania extends into mid-April each year is the new norm, and steps need to be taken to ensure that sufficient natural grass greens are available in the latter stages of each season to ensure its satisfactory conclusion. This has already come to the attention of the Board and will no doubt be a priority issue that will require resolution early in the 2020-21 pennant season, in partnership with clubs that maintain natural grass greens.

The BTS 2019-20 pennant season was not without controversy with the Board's decision to amend its Conditions of Play for the season by suspending all promotions and relegations at the end of its Saturday Pennant season to enable the introduction of divisions of eight sides each (as compared with the current ten sides per Saturday division) for the 2020-21 pennant season. This caused a great deal of concern amongst a number of clubs resulting in a Special General Meeting being called, at which the specific changes to Conditions of Play, enabling the introduction of Saturday divisions of eight sides each, were removed on the passing of a resolution seeking their deletion. Rather than considering this as a defeat for the Board it should be celebrated as democracy in action in our Association.

The reduction of divisions, especially for BTS Saturday Pennant, is still an issue for some bowlers, especially in the higher divisions, who are keen to increase the level of competition, week in week out, by limiting the number of sides in Premier Division, especially, to eight sides. The belief is that the skill level in each of the eight sides will be increased due to the number of players required reduces from 160 to 128, meaning that all matches each week should result in closer competition. Of course, there are competing interests between players requiring stronger competition and clubs reliant upon the maximum number of home games possible to assist with their financial viability. It is reasonable that both viewpoints should be considered, and there are ways in which the desire of players for stronger competition can be met while also ensuring that clubs do not suffer reduced capacity for financial gain. The

door should not be closed on this issue, and we should engage in ongoing dialogue to seek a satisfactory win-win resolution.

The BTS 2019-20 pennant season has highlighted several other areas of growing concern, the viability of Women's Thursday Pennant Division 5 and Saturday Pennant Division 7. Thursday Division 5 became a two-rink competition several seasons ago due to the high number of forfeits resulting from clubs' inability to find sufficient numbers to fill their sides in this division. Since that time, the number of sides that play on a regular basis has reduced to six. In the season just concluded, the ladies participating in Thursday Division 5 suffered many disruptions through regular forfeits at the beginning of the season, then the withdrawal or reconstitution of sides and an eventual redraw of the roster, all of which would have been quite unsettling.

In the BTS Saturday Division 7 competition a number of forfeits also occurred due to individual clubs suffering from a temporary shortage of players. This is understandable, as the lowest division is always the last to be "filled", the higher divisions taking preference for players. In both of these pennant divisional competitions hard decisions need to be made by the clubs involved (or potentially involved); firstly, in regard to what number of sides make a pennant division competitive (i.e. Thursday Division 5; are six enough to make it viable?) and secondly, should a reduction of rinks per side in a division be considered to assist clubs to field full sides (i.e. Saturday Division 7 reduced from a three-rink to a two-rink competition).

Adherence to the Bowls Australia National Merchandise Program Logo Policy has been of increasing concern from the highest levels of administration of bowls in Australia, and particularly for Bowls Tasmania and Bowls Tasmania South. Ultimately, it is the responsibility of club administrators to ensure that all of their players are dressed appropriately, and in the approved manner, each time that they represent their club in officially sanctioned bowls competitions. Following several incidents of non-conformance to the Bowls Australia policy recently by several clubs in the south, the Board has amended its uniform policy to remove any doubt or ambiguity. Notwithstanding this, the Bowls Australia policy in this regard is paramount and supersedes anything that may be stated in the BTS Uniform Policy.

An amendment to BTS Conditions of Play, introduced by the Board during the season, was an initiative which allowed older, less mobile or infirm members to "share" a role on a rink, either by playing for a number of ends and then being replaced by an alternate player, or playing in a position in the team from one end while the alternate player bowled in the same position from the other end. This initiative was introduced in recognition of the vital role that bowls plays in the support of the mental health and wellbeing of elderly members, and the important social interaction that comes from involvement in our sport. It was also introduced as a means of retaining players by extending the period of their involvement. It was very pleasing to see how enthusiastically this initiative was adopted by clubs. satisfying is that Bowls North has indicated that this "rink-role sharing" initiative of BTS will be adopted into their Conditions of Play for their 2020-21 pennant season as a result of their analysis of player retention (or lack of it!) in the north, which identified the loss of older members as being most significant of those who failed to renew their player registration year by year. Time will tell if this initiative is successful in reducing the number of older players who drop out of bowls, but as an inclusive sporting community it is most satisfying that it is being incorporated into the selection procedures of clubs.

A major impetus of the Board over the past several seasons has been to lift the status of the BTS Men's Midweek Pennant competition. the change from a four- to a three-rink competition in 2018-19, resulted in a number of clubs being able to enter an additional side, and a further amendment, prior to the commencement of the 2019-20 season, whereby the A-B Grade restrictions were removed, encouraged more players to make themselves available for selection in the Midweek Pennant, which enables several clubs to enter an extra side resulting in all four Wednesday divisions having a full complement of ten sides each.

At present, bowlers who participate in BTS Midweek Pennant are denied the opportunity of participating in a State Pennant Final at the end of each season, unlike bowlers in BTS Thursday and Saturday pennants. This is a matter the Board has been working on during the 2019-20 season with the Bowls Tasmania Board agreeing to provide trophies and medallions for such an end-of-season inter-regional competition – if the regions (BTS and Bowls North West) can agree on a format. BTS has presented a format proposal to Bowls North West which has committed to consider it over the winter months and make a decision prior to the commencement of the 2020-21 pennant season. If this proceeds it will mean that bowlers participating in BTS Midweek Divisions 1 and 2 (Bowls North West has only two Midweek divisions) will have the additional incentive of participating in a Bowls Tasmania Midweek State Pennant Final – an incentive, also, to bowlers in BTS Midweek Divisions 3 and 4 to press for promotion to the top two divisions. An exciting prospect, and another step along the way to removing the stigma of this competition being a "social' event."

Bowls Australia's new BowlsLink database and competition portal was introduced at the commencement of the 2019-20 bowls season and heartfelt thanks go to Paul Hoddy for his sustained effort in supporting clubs in their use of this new computer program. Overall, the early adoption by most clubs was very pleasing, although there were still a small number of clubs at the end of the season with ongoing concerns. At present BTS is in the process of formulating a BowlsLink policy to provide guidelines to clubs to ensure improved usage in future. From the beginning of the 2020-21 bowls season entries to BTS championship events will be accepted through BowlsLink, with draws for each championship event being conducted automatically through the program.

For the Board, it has been "business as usual", but slightly different, during current social distancing restrictions. Board meetings have been conducted remotely through video conferencing apps and subcommittees have been able to meet using the same processes. Elements of the current BTS Strategic Plan are being progressed, with work through the winter months concentrating on a review of all BTS policies. The Board sub-committee appointed to this task is meeting weekly via video conferencing, with completed drafts being prepared for discussion and ratification at monthly meetings of the Board. It is the aim of this sub-committee to have all policies reviewed and updated before the commencement of the next bowls season.

I have enjoyed another year interacting with the other members of the Board as we work together on behalf of the Association. I cannot speak highly enough of BTS Secretary, Rob McGuire. He is an absolute asset to me and to the Association. Rob provides sterling service in all that he does on behalf of the Association, and always to a standard beyond expectations. Of course, he is a person of strongly held opinions which does not auger well with others, but it is his strong commitment to service to the Association that I admire most. Most of all, I appreciate his counselling and advice that he provides to me.

In Treasurer Tony Fulton the Association has a quality financial advisor whose budgetary support for the Board is knowledgeable and accurate at all times. Tony has excellent understanding of fiscal issues and has ensured that the Association's finances are managed in a manner that makes funds are available to support all aspects of bowls actively while also ensuring that costs to affiliated clubs, and their members, is kept to the minimum sustainable levels.

Deputy President Pat Zapotocky has been an asset to BTS in RCC meetings, and as a member of the BTS Finance Committee, while Malcolm Salier is a strong advocate on the Board for smaller clubs, and especially for clubs with synthetic greens. Leonie Price, the BTS Officiating Panel representative on the Board, gives quality input to the Board in regard to the interpretation of the Laws of Bowls, in the annual review of BTS Conditions of Play as well as the annual upgrading of the BTS Side Captains Duties document.

Ross Bannister undertakes a number of important roles on the Board, as Chair of the BTS Match Committee, and as the coaches' nominee. In each of his roles Ross provides quality service to the Association. Ailsa Milburn is a valuable resource for me, especially in regard to corporate memory, and is always willing to step up and take on additional duties. Ken Coppleman has worked through some very difficult times, personally, but has still been able to make significant contributions, most recently in the writing of the BTS Member Protection Policy. New to the Board this year, Lyn Triffitt's activity on the Board has been restricted by her work commitments but she has made significant efforts to secure sponsorship support for the Association.

BTS has had significant difficulty in recent times in attracting sponsors to assist it to reduce its reliance on capitation fees to support bowls programs in southern Tasmania, and has been without a major sponsor since DJ Motors ceased its involvement several seasons ago. Even securing minor sponsors has been a major struggle which is why the Board is most grateful to the assistance provided by Robert Winterbottom at the beginning of the season in the identification and securing of *Typeface* as sponsor and printer of the BTS scorecards. As a result a distinct, colourful scorecard was available for each pennant match across all divisions of all competitions during the season.

Doug Cole remains a strong supporter of the BTS Junior program, donating the funds required to enable the presentation of prize money to the winners of BTS Junior Championship events. Although Doug intended to support the junior championship program for 2019-20 unfortunately all of these events were cancelled due to the restrictions placed put in place by the State Government in its efforts to control the spread of the Coronavirus pandemic. We are hopeful that Doug will be able to resume his involvement next season.

The junior program was of concern in the early part of the season due to the low number of participants in the weekly training sessions conducted Friday afternoons at the Buckingham Bowls Club. Initially, it appeared likely that BTS would have to forfeit the first round of the Junior Statewide Challenge as only five juniors had indicated a willingness to attend the sessions and with a team of ten required it did not seem possible that a team could be formed to take part, even though it was known that BTS had more than the sufficient number of juniors registered. After considerable effort by the BTS Secretary, BTS was able to field a competitive side. As a consequence of this experience the Board decided that it would seek to appoint a Junior Development Officer for future seasons to act as a liaison between the junior coach, junior players, their parents and their clubs, to ensure that all junior players are aware of the junior program, its benefits to their bowls development, and to the opportunities available to them through their participation.

Whilst the abrupt end to the season took considerable joy from the celebrations that normally occur with the successful conclusion of the annual pennant campaign, there are considerable individual and team successes to celebrate. Congratulations to the BTS Bowlers of the Year: Lyn Triffitt (Open Women), Keghan Booth (Open Men), Ingrid Makowski (B Grade Women) and Michael Hall (B Grade Men).

Bowlers from the South enjoyed considerable success in the various Bowls Tasmania Championship events, also: congratulations to the winners of their respective events go to: Sonia Martin (BTAS Women's Open Singles), Damien Sutton (BTAS Men's B Grade Singles), Geoff Munro (BTAS Men's Bowling Arm Singles), Marijke Raine (BTAS Women's Disability Singles), Jorja Maughan and Laura Banks (BTAS Women's Open Pairs), Jason Dent (BTAS Men's Disability Singles), Will Coad and Robert O'Neill (BTAS Men's Open Pairs), Paul McCann and Keith Hinkley (BTAS Senior Pairs), Will Coad (member of the composite team successful in the BTAS Men's Open Triples), Geoff Munro and Kevin Booth (BTAS Men's Bowling Arm Pairs), Jenny Suttie (member of the composite team successful in the BTAS Women's Open Triples), Peter Bannister, Steve Graf, and Connor and Leigh Munnings (BTAS Men's Open Fours), Bill Mottershead and Mark Quinane (BTAS Men's B Grade Pairs), Bill Mottershead, Mark Quinane David Lovett and Charlie Thomas (BTAS Men's B Grade Fours), and Kerry Hill, Peter Clark, Anthony Watson, and Wayne Clark (BTAS Men's Senior Fours).

Planning for the BTS bowls season in 2020-21 is progressing as if it will be "business as usual" but, in reality, no one can yet predict what our next year of pennant bowls will look like. Hopefully, the abrupt and premature end to our last season, and the lack of opportunity for any bowls activity during the winter months, either for those who normally escape our icy winters for sunny Queensland, or the stay-at-homes who brave the numbing chill on outdoor greens (or the relative comfort of the two indoor centres), will be champing at the bit to get into full swing again.

One of the attributes required of anyone taking on a leadership role in a sporting organisation is the ability to understand the limitations to the extent to which one may make unilateral decisions. In fact, the health of the organisation worsens in direct response to the degree in which decisions are made by the leader without involving the full board. I am pleased that I am a leader of a team in which everyone participates to the fullest in every decision that is made on behalf of the Association. There is more work to be done, I have the energy to lead the process and I respectfully request your endorsement so that I am able to continue to provide service to the Association. May season 2020-21 be one without incident or disruption!

COACHES PANEL REPORT

Last winter from June through to September on the first Sunday of the month coaching sessions were held at the Howrah Indoor Centre with over thirty people attending each Sunday. On behalf of the coaches who assisted with the training, I would like to thank the Howrah Bowls Club for opening their club on these Sundays and making it available for the coaching sessions and Bowls Tasmania South for paying the hire fee allowing members from other bowls clubs to come and use the indoor centre for free.

This winter's coaching sessions have had to be cancelled due to the shutdown of clubs as a result of the Coronavirus pandemic, but we may be able to hold sessions if the restrictions are lifted later in the year.

The southern junior boys and girls also had training sessions over the summer months on Friday nights conducted by the southern junior coach Ricky Maughan at the Buckingham Bowls Club. At the start of the season our junior numbers were down but due to the great organising from their coach and helpers they recruited players to fill their team and did BTS proud in the Junior State Wide Pennant.

For some reason lawn bowlers don't want coaching, maybe it shows up something we can't do on the green, where in any other sport coaching is a big part of the game.

Our southern Coaches Panel members are more than happy to travel to any bowls club that needs help in running or organising bowls coaching sessions. If any clubs would like to organise a coaching day all they have to do is contact the Coaches Panel or myself.

Last year most of our southern coach's certifications have expired or will soon expire. It is very simple to be re-qualified as a club coach by having your bowls club write a current competency letter saying that you have been actively coaching at your bowls club, fill out an application form, supplying a photo copy of your Working with Vulnerable People card and watch the coaches den videos on the Bowls Australia web site. The re-certification fee is \$25 to cover the cost of a new certification card.

There have been coaches courses run in the south last season with bowlers gaining the coaches certifications so if your bowls club does not have a qualified bowls coaches, you need to talk to your clubs committee and arrange to get qualified. Every bowls club in the south should have at least two female and two male coaches in their club. If you would like to become a coach or know of somebody that would be a good lawn bowls coach please let me know and we can organise your registration through Bowls Tasmania for the next southern club coaches course.

The Roles and Responsibilities of Umpires and their Duties will be posted to the BTS website when the site is updated.

Lists of Officials, Measurers and Markers to assist clubs with the conduct of events are accessible from the BTS website, thanks to Helen Ducker and Ross Bannister. The Panel will help clubs that are unable to find sufficient Officials for BTS or Bowls Tasmania events.

The Panel conducted meetings at least once every month through the bowling season and appointed Officials for all BTS championship finals. Appointing Markers for BTS Singles Finals was successful - this initiative ensured that singles events had competent markers.

Forums for Officials continued during the season and proved popular with over forty attendees. Thanks go to the Kingborough, St Johns Park and Howrah Bowls Clubs for hosting the forums which will continue in this format for the next season.

Thanks go to Ross Bannister for his continuing work on training Measurers, Markers and Umpires. These programs are also now available on-line through the Bowls Tasmania website.

Finally the Panel would like to thank all the numerous Officials that have given their time to BTS Championship events and Pennant Finals.

Treasurers Report

We have been able to carry forward a small excess of receipts over expenditure this season due largely to the COVID 19 virus impact with suspension of some championships and part of the Statewide Challenge reducing expenditure.

Conversely those issues will impact on our projections for next year as we await advice as to whether these events will in fact still be completed.

At the time of writing this report we have not received advice from Bowls Tasmania on capitation fees for 2020/2021 and what events will be carried forward to the new season however we have been advised we will be able to report on those matters at the Annual General Meeting.

During the season we took the decision to switch our accounting platform from MYOB to Reckon mainly as a cost saving measure. The conversion went well however we detected that a post audit transaction relating to 2018-19 impacted marginally on year's figures resulting in an overstatement of \$351 in our retained earnings. The last year amended figures are shown in this report.

I acknowledge the support of our Auditor, Mr. Rendell Ridge, in resolving the issue and members of the Bowls South Board for their support during the change.
