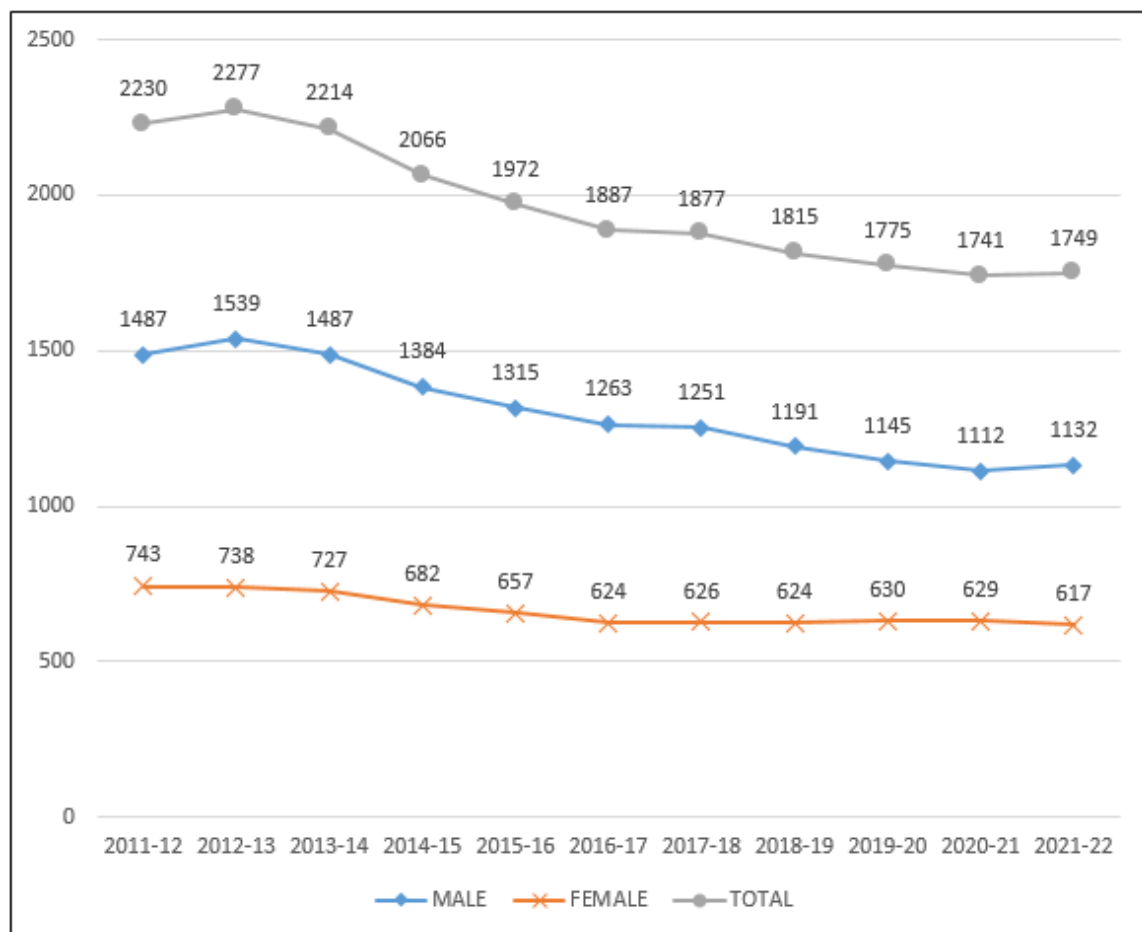

## PRESIDENT'S REPORT

In presenting my report to you for this year I do so in the hope that finally, after three seasons of disruption caused by the Coronavirus that we might at last be heading towards some form of normalisation, and that we can look forward to an uninterrupted pennant season in 2022-23.

At the conclusion of the Annual General Meeting in May, 2021, the Board commenced the year with vacant positions of Deputy President, Treasurer, and an ordinary Board member (male). This was the commencement of a very difficult year of operation for the Board, with a number of changes to the personnel on the Board occurring over the course of the year. It was very pleasing that, in the first instance, Deb Jeffrey accepted an invitation to perform the duties of Treasurer, a role that Deb has performed at a very high standard. Anne Mullavey did not remain long in her position on the Board, nominating for the position of Bowls Tasmania Elected Director (female-South) and then succeeding Liz Rickards in the position. Ailsa Milburn then accepted the role of Deputy President and Christine McGrath came onto the Board as Ailsa's replacement as an ordinary Board member. Geoff Price was also invited to join the Board as an ordinary member.

The most significant change in personnel, though, was the resignation in September of our long serving Secretary, Rob McGuire, to take up his appointment of CEO, Bowls Tasmania. After a protracted search for a replacement Paul Matthews accepted the role of Secretary, stepping into the position just prior to the commencement of the pennant season. This has been a huge year of adjustment for Paul in the role but I am very pleased with the way in which he has adapted to the position.

During the year there were a number of resignations from the Board, firstly Ailsa before the Christmas break, then Christine who found that the responsibility of caring for her mother did not leave her time for her role on the Board. For personal and health reasons Leonie and Geoff Price made the difficult decision to resign from the Board, also. In the latter months of the year, with the number on the Board falling to six, the minimum required for a quorum, the two Geoff's, Geoff Dannock and Geoff Price, accepted invitations to join the Board for the remainder of the year. I would thank, sincerely, the other members of the Board who have been constant throughout the year, Ross Bannister (Chair of the BTS Match Committee), Michael Andersch (BTS Officiating Panel nominee) and Paul Hoddy (BTS Statistician and Executive Assistant), all of whom made significant contributions to the Board's operation and functioning.

Through all the disruption to the Board caused by the comings and goings of various members the Board has achieved significant outcomes in the review and updating of a number of policies, in particular the BTS Discipline, Uniform and Selectors, Coaches and Team Managers policies, as well as ratifying the new policies for Club Suspension of Players and Gender Identity Inclusion. In addition to this work the Board has been proactive in the development of policies and guidelines relating to governance issues in

the ratification of policies for BTS Board of Management Code of Conduct, BTS Board of Management Conflict of Interest, and BTS Committees, guidelines for the BTS Finance Committee, and for the Recording of Minutes for Board Meetings, and protocols for the annual review of BTS Conditions of Play.

The most significant achievement of the Board, though, has been the adoption of a new method of calculating and charging annual affiliation fees to clubs. The ratification of the new procedures in December enabled the introduction of the new fee structure for the 2022-23 BTS financial year. With receipt late April of the affiliation fee Bowls Tasmania is charging BTS for the ensuing year the BTS Budget for 2022-23 was completed, enabling the calculation of affiliation fees to be charged by BTS to each club. An advice of the 2022-23 affiliation fee has been distributed to each club to assist in their budgeting processes for the new financial year.

A complex issue facing all organised sport is the gradual and annual decline in participation and bowls is no exception. The Board is very hopeful that the new affiliation fee structure will make it easier for clubs to introduce new players to pennant play, and thus grow their membership, by removing the significant cost of initial registration. The Board has recognised that there will be significant “start-up” costs and has determined to establish a fund from accumulated reserves which clubs can access to offset some of those costs. It is hoped that by providing financial assistance to clubs to aid their recruitment efforts will have positive results.

Similarly, we have a very small number of juniors in the South, and with a several of our current juniors soon to turn 18 it is possible that we may not have sufficient juniors to field a full Junior State Wide Challenge side. While many clubs make their facilities available for school groups to conduct either one-off or short-term bowls-related activities, the Board is interested in providing financial support to clubs that wish to conduct more formal activities, even junior competitions, to develop an interest in this cohort to take our sport competitively. To this end, another fund has been established for reserves for clubs to access on application. More details of both grant programs will be forwarded to clubs during the off-season to encourage the development of club-based programs, as well as to provide details on the application process.

The 2021 Australian Championships were held during April, postponed from October last year, and our 2021 state champions performed exceptionally well, gaining a medal in all but one of the events contested. Participants from southern Tasmania receiving a Silver Medal were Jorja and Isaac Maughan (Mixed Pairs), and Will Coad (member of the Men’s Triples team). Receiving a Bronze Medal were Crystal Brooks and Barbara Liddington, who were members of the composite Women’s Open Fours team.

Southern bowlers that experienced success during the season participating in Bowls Tasmania Gala Week championship events were: Lyn Triffett (State Women’s Open Singles Champion), Peri and Yvonne Buckley (members of the State Women’s Open Fours champions), Grant Wakefield (member of the State Men’s Open Pairs), Will Coad and Ryan Guy (members of the composite team that won the State Men’s open Fours), Lyn Triffett and Sue Mann (State Senior Women’s Pairs Champions), Rosie Geeves, Lyn Page, Janet Rutherford and Anne Mullavey (State Senior Women’s Fours champions) and Roger Dale and Craig Griggs (State Men’s Open Pairs champions).

There was a clean sweep by southern bowlers in BTAS Men's B Grade Championship events with Matthew Gregg (Singles), Brad Johns and Duncan Carey (Pairs), and Owen O'Driscoll, Paul McCann, Neville Riseley and Barrie Cranwell (Fours) successful in their respective events. In the BTAS Women's B Grade Championships the team of Judy Reeve, Dellis Voss, Kristy Harrison and Emma Burgess won the fours event.

Further individual success in state level competitions were achieved by Lyn Triffett (BTAS Champion of Champions Women's Open Singles), and Isaac Maughan and Denise Tanner (winners of the Australian Indoor Singles Qualifiers held at the Howrah Indoor Centre recently). Congratulations, everyone, on your individual and team successes at both state and national level.

Congratulations to Jeanette Lane (Women's Open), Val Gregg (Women's B Grade), Peter Bannister (Men's Open) and Duncan Carey (Men's B Grade) for achieving the personal accolade of being named BTS Bowler of the Year for 2021-22. Consistency over all BTS events, singles, pairs, triples and fours contributed to the success of the four bowlers named and it hoped that more bowlers take up the challenge of participating in BTS championship events in 2022-23.

Due to the amount of adverse comment in regard to Thursday State Pennant Finals, and the withdrawal of support for this event by both Bowls Tasmania South and Bowls North West, the Bowls Tasmania Board made the decision not to conduct this competition in 2021-22, but decided to persist with Saturday State Pennant Finals in the same three-rink format as in previous years. It is noted that the winners of the BTS Saturday Pennants for Premier to Division 6 all accepted BTAS's invitation to participate, with three sides, Sandy Bay (Premier Division), New Norfolk (Division 1) and Cremorne (Division 4) winning the State Pennant in their divisions. Particular mention must be made of Cremorne which achieved its first-ever State Pennant in the club's history. Congratulations for the completion of a very successful season!

I take particular interest in the progress of individual clubs and have always taken the opportunity to make special mention in my annual reports of standout performances during the season, and this year is no exception. During the season just concluded I have been most impressed by the performance of the Claremont Bowls Club across all pennant competitions, and I have come to understand that much of this is due to the amount of effort put into player development across all divisions. Experienced players providing support and encouragement to beginning bowlers, and to those progressing through the lower grades is an excellent model for all clubs to adopt, and Claremont appears to have been able to do this in a very supportive and empathetic environment. Therefore, it is not surprising that the club had so many of its sides participating in the finals series of all three BTS pennant competitions and won the pennant in Division 4 of Women's Thursday Pennant, Division 2, Division 3, Division 5, Division 6, and Division 7 (Claremont 2 defeated Claremont 1 in the Grand Final) of Saturday Open Gender Pennant. As a result, Claremont was justly rewarded for a magnificent season when awarded the Fitzgerald Trophy for the best-performed club for 2021-22. Congratulations, Claremont!

Although sometimes the scourge of participants it is impossible to conduct any organised sports competition without a set of rules (or laws) to govern the game, and someone is required to adjudicate those rules or laws during play to ensure that the game proceeds



in an orderly fashion. The sport of bowls is no different and we in the South of the state are fortunate to have a well-organised group of officials who are led in excellent fashion by the BTS Officiating Panel. I commend the diligent manner in which the panel prepares our officials through workshops and seminars at the commencement of each season, providing both practical and law-related activities to ensure that our officials can perform at a high standard. I also commend the panel for the manner in which officials are developed through mentoring activities during BTAS Gala Weeks and BTS Championship events.

In regard to our officials, I would make special mention of our two International Technical Officers (ITO's), Leonie Price and Michael Andersch, who have attained the pinnacle of officiating in World Bowls, and are the only ITO's in the state. This is an excellent personal achievement and is testament to a high level of understanding and application of the laws of bowls, but what is more important is that both Leonie and Michael spend much of their time imparting their knowledge, expertise and experience on to our National Umpires. We are very fortunate to have such quality officials in our ranks and has ensured that the umpiring group in the South are the best available anywhere in the state.

A growing phenomenon is the steady increase in the number of clubs in the South that have either converted their single grass green to synthetic or have a mix of grass and synthetic greens. By the commencement of the 2022-23 BTS pennant season 15 clubs in the South will have a synthetic surface, including the two clubs with indoor bowls centres, and a further two will be in the process of converting a grass green to synthetic. The reasoning behind the change is understandable as the high cost associated with maintaining a grass green to a satisfactory standard can be prohibitive for smaller clubs, and the ability to provide social bowls activities during the off-season, and the additional revenue that this can generate for a bowls club, can be too attractive to forgo the installation of a synthetic surface. No doubt there will be increasing pressure to ensure that there truly is no distinction or bias between a natural or synthetic surface and that the playing of major regional and state events on a synthetic surface is more likely than not. It behoves us all to change our attitude to the possibility.

During the past nine months or so we have witnessed a seismic shift in our state body, Bowls Tasmania, with the resignation of the previous CEO, Rebecca van Asch, to take up a position with Bowls Australia and her replacement, Rob McGuire, being appointed. While this caused a major shakeup of administrative structures for BTS it has resulted in the move of BTAS office facilities from its former base at the Invermay Bowls Club in Launceston to Sport and Recreation House, Cornelian Bay. With the recent retirement of Graham Hay from the position of President, BTAS, and the election of our male Elected Director on the BTAS Board, Bernard Knight, to that position I do not believe it would quite accurate to continue to claim that we are "ruled from the North". I do take this opportunity, though, to congratulate both Rob and Bernard on the appointment to their respective BTAS positions.

Seeking sponsorship for our sport is always a difficult task, especially for one such as ours which is considered by many to be minor and only played by those wishing to partake in passive physical activity in their retirement. Despite this, BTS does have two very valuable and highly respected sponsors in Derwent Eye Specialists, which sponsors our Saturday

Premier Division, and Doug Cole, who has been the sponsor of our junior program for many years. We are honoured to be associated with both of our sponsors and look forward to their continued involvement into the future. At the present time negotiations are continuing with another potential sponsor and it is hoped that an official announcement in this regard will be possible before the commencement of the 2022-23 BTS pennant season.

I remain committed to my role as president of Bowls Tasmania South, and that I still have the desire to serve the southern bowls community in this capacity. Even during the most difficult periods of the past year I did not consider relinquishing the role. In my time as president we have achieved a great deal, but yet there is more to be done. While I am still of the belief that I have more to contribute I will put myself forward for consideration for the position.

Once again we tried to spread the championships around different bowls clubs this season but it's very difficult with some clubs not willing to hold Bowls South championships. Congratulations to the winners of all of our championships as well as those pennant teams that won finals or gained promotion.

Some southern bowls club had pennant points taken of them this season and other clubs have had warnings when they have breached the BTS conditions of play for pennant. This seems to happen every season The Match Committee and Bowls South can only apply the rules that are in the Bowls South Condition of play and cannot deviate from them.

Also several southern clubs put in complaints this season about green conditions and the speed of the greens. It clearly stated in the bowls south condition of play what match managers are supposed to do, it's up to each club to make sure there match managers know the procedures. If the proper procedures are not followed, the match committee has no option but to reject the complaint even if it is valid.

As several southern clubs are installing or looking at installing synthetic greens it leave only a hand full of bowls clubs with two grass greens. BTS championships were mainly played on the grass greens with two or more greens normally required for the events but this will have to change in the future and some championships will have to be played on synthetic surfaces if there are no suitable grass greens available.

I have said this for many years now for some reason most lawn bowler don't want coaching, may be it shows up something we can't do on the grass green or the synthetics, were in any other sport coaching is a big part of the game may be it times for change.

Our southern coach's committee members are more than happy to travel to any bowls club that needs help in running or organising bowls coaching sessions. If any clubs would like to organise a coaching day all they have to do is contact the southern coaches' panel through Bowls South.

Most of our southern coach's certification has or will expire this year and it is very simple to be requalified as a club coach by having your bowls club write an current competent letter saying that you have been actively coaching at your bowls club, fill out an application form, supplying a photo copy of your working with vulnerable people card and watch the coaches den videos on Bowls Australia web site. The recertification fee is \$25.00 to cover the cost of a new certification card.

There have been coaches certification courses run in the south this season with bowlers gaining there coaches certifications so if your bowls club does not have a qualified bowls coaches, you need to talk to your clubs committee and arrange to get qualified. Every bowls club in the south should have at least two female and two male coaches in their club. If you would like to become a coach or know of somebody that would be a good bowls coach please let me know and we can organise your registration through Bowls Tasmania for the next Southern Club Coaches course.

## OFFICIATING PANEL REPORT

The Bowls Tasmania South Officiating Panel members are Helen Ducker, Leonie Price, Janet Rutherford, Wayne Cobbing and Michael Andersch. Janet and Wayne have recently joined the panel to assist spread the workload and provide a more diverse representation of Clubs in our group. They have been regularly umpiring and marking in the season's events. We look forward to our larger Panel supporting each other and the wider community of officials in the development of their umpiring, marking and measuring skills.

The Panel conducts regular meetings during the bowling season to manage appointments to events. We have a strong working relationship with the Match Committee for BTS events, championships and Pennant Finals as well as Bowls Tasmania for Gala Week, State Pennant Finals, Regional Round Robin and Indoor Qualifying.

Our Side Captain's Guidelines has its usual annual upgrade after refinement to the Conditions of Play for the season and key elements are reinforced with Officials attending our start of season forums. We do need to emphasis to Clubs that the Side Captain's Guidelines is essential reading at the start of each season, to ensure a good level of awareness is maintained around the Laws, Protocols and conduct for the playing in and the managing of BTS Pennant and championships.

This year's update to the BTS Uniform Policy had a good level of discussion across the season and in our Officials Forums. Likewise, the recently introduced Greens Protection Policy and its application by umpires and/or Side Captain also had much discussion, mostly in the context of pennant events. Umpires, who in many situations are a home side player, need to be impartial in their measuring, law directions to players and at the same time ensure that 'Duty of Care' is applied.

Umpires should be constructive and informative when educating players as to their rule indiscretions and at the same time, not appear over-officious and pernickety. It is a fine balancing act for Umpires, some of whom are reluctant to be "Fashion Police" or "Sticker/Date Stamp Auditor"

Approaches by umpires to "treading softly" around contentious enforcement of Laws and/or interacting with players is shared and discussed in our Officials Forums. Many find an early and prompt "friendly reminder" will circumvent the need for any official warning to be issued.

Lists of Umpires, Measurers and Markers are accessible from the BTS website and should be used by Clubs to find Officials for the preliminary rounds of events held at their venue. Our BTS Secretary updates our "Useful Information" section of the website to cover Match Committee and/or Umpires rulings on circumstances not directly covered in current laws or the Conditions of Play.

We need to acknowledge and thank Ross Bannister for his continuing work training and accrediting Measurers, Markers and Umpires. These programs are booked via the Bowls Tasmania website.

Thanks also to the dedication and time given by our Panel Members and all Club Officials across the season and its events.

## TREASURER'S REPORT

As this is my first year as BTS Treasurer, I'm pleased to present the following report.

With the 2021-22 season continuing to work its way through COVID challenges, and slowly finding our way to the new norm, BTS finished the financial year slightly above our budget projection with a deficit of \$2,628. This year the major contributor was a 28% unexpected increase to registrations. Overall, the numbers are still low but much less than expected.

As mentioned in last year's Treasurers report, Bowls Tasmania changed over to a flat fee revenue system which they continued through to the 2022-23 season. With the fees set, BTS will pay \$102,495.80, North will pay \$76,021 and North West will pay \$70,083.20 including GST.

After extensive investigation and positive feedback from other states, BTS decided to also move to the flat fee revenue system for 2022-23 season.

By now each club has received their advanced affiliation fee notice which we hope will help clubs with their annual budget. As previously advised, this calculation is based on your BowlsLink player registrations as at the census date, 28th February each year. BTS will provide each club with a tax invoice in early September, and payment will be due on 1st October 2022.

The move to the flat fee system provides many advantages for clubs above and beyond budgeting, and means that clubs will:

- no longer need to send 'out of season' transfer forms or payments
- no longer pay for juniors
- no longer pay \$50 registration fee per side
- no longer need to send registration forms
- no longer pay capitation fees per person during the bowls season.

All movement of players or registration of new players is through BowlsLink, so no more emails or paperwork is required.

In 2022-23 BTS will be focusing heavily on junior development plus club development in general. We have budgeted an operating loss of \$2,569. We have also budgeted a further \$46,200 from our surplus for a NEW Junior Development and Club Incentive Program, bringing our nett loss to \$48,770. More details will be provided in the coming months. BTS feels strongly about injecting some of its surplus back to the clubs in these uncertain times ahead.

**General Business:**Item submitted by Cremorne:

Cremorne wants clubs to determine whether or not Conditions of Play 3.24 should remain the same (i.e. current format) or revert back to the previous rule whereby clubs have to specifically nominate a green surface prior to the start of the pennant season. The BTS Board considered this at its last meeting and recommended a change to Conditions of Play as per the motion below.

Moved: Don McVilly Seconded: Shirley Hay “that Clubs with both grass and synthetic greens will be required to advise before the start of each season which surface each division will be playing pennant on. Changes to this will then only be permitted:

- By giving four days’ notice in writing to the opposing Club, or
- If the green is closed due to unforeseeable circumstances including inclement weather, or
- By mutual agreement between the side captains.”

**Social Media Policy:** Don McVilly (Cremorne) suggested that BTS should consider having a Social Media Policy outlining what behaviour is and isn't allowed on social media and in particular on Facebook. President Peter Kirby advised that BTS does have a Social Media Policy which can be found on the BTS website.

**Saturday Pennant Division 7:** Don McVilly (Cremorne) asked what was happening re Saturday Pennant Division 7 for next season. At the Delegates Meeting in April 2021, Cremorne advised that it would like Division 7 games to be restored to three rinks (i.e. 12 players) and the ends played reduced to 15. At the Delegates meeting it was suggested that there be two Division 7's – one with two rinks and one with three rinks. It was also suggested that Division 6 be increased to more than ten teams to allow sides that want to play with three rinks to move up to Division 6. The general consensus was that 18 ends would be preferred over the suggested 15 ends. Delegates agreed that this matter should be taken back to Clubs to decide with a number of options offered. President Peter Kirby noted that if Division 7 had been three rinks last season there would not have been a Division 7. He further advised that the BTS Board agreed to seek the opinion of Clubs re Division 7 as outlined above.

**BTS Treasurer:** Heath Seabourne (Dover RSL) asked what will happen as there is no BTS Treasurer at present. President Peter Kirby advised that this position will be filled as soon as possible as a casual vacancy by the BTS Board.

**Special Resolutions**

Pauline Connell (Kingborough) moved, and Don McVilly (Cremorne) seconded that, by special resolution of the members of the association, Section 8 of the constitution be amended as described in Annex A. **CARRIED** by absolute majority (100% for)

Don McVilly (Cremorne) moved, and Ross Bannister (North Hobart) seconded that, by special resolution of the members of the association, Section 32 of the constitution be amended as described in Annex B. **CARRIED** by absolute majority (100% for)

Don McVilly (Cremorne) moved, and Peter Krstic (Cremorne) seconded that, by special resolution of the members of the association, Section 33 of the constitution be amended as described in Annex C. **CARRIED** by absolute majority (100% for)

Leigh McAdam (Glenorchy City) moved, and Neale Hall (Glenorchy City) seconded that, by special resolution of the members of the association, Section 41 of the constitution be amended as described in Annex D. **CARRIED** by absolute majority (100% for)

## Annex A – Details of Special Resolution 1

That, by special resolution of the members of the association, Section 8 of the BTS Constitution (2016) be deleted and replaced by the following:

### **8 MEMBERSHIP AND CAPITATION FEES**

- 8.1 The annual membership and/or capitation fees for Clubs and Provisional Clubs shall be determined by the Board.
- 8.2 The secretary of each Club shall maintain an accurate membership database in a format prescribed by the Board."

#### **Reasons:**

1. The current Rule 8 is no longer compatible with current practice in regard to the manner in which Bowls Tasmania calculates and charges annual fees to the regions.
2. Bowls Tasmania no longer uses a per capita model for calculating annual subscription fees to the regions, as referred to in current Rule 8.2. Bowls Tasmania's annual fee charged to regions becomes part of the region's annual expenditure budget.
3. There is no need to reference, in the BTS Constitution, annual fees that Bowls Tasmania charges to regions. The BTS annual budget advises the revenue required to bring BTS finances into balance and this amount determines the total funds required to be raised from capitation fees BTS charges to clubs. It is not necessary for these matters to be articulated in this rule.
4. Current Rule 8.3, which requires club secretaries to forward to BTS a list of each club's playing members to be registered, is no longer relevant and has been superseded by the BowlsLink database.
5. Bowls Tasmania is using the BowlsLink database already to calculate the proportion of funds to be paid by each region in the form of an annual capitation fee. It is vital that the database contains accurate information in regard to actual numbers and the proposed new Rule 8.2 instructs Club secretaries of their responsibility in this regard.
6. The proposed new Rule 8.1 retains the power granted to the Board to set annual fees that it charges to its affiliated Clubs but permits flexibility in the manner in which annual fees are calculated as well as the date by which payment is due. For flexibility of operation it is appropriate that these matters should be omitted from the constitution to permit the ability to adjust to changing circumstances without coming into conflict with specific rules of the constitution.

## Annex B – Details of Special Resolution 2

That, by special resolution of the members of the association, Section 32 of the BTS Constitution (2016) be deleted and replaced by the following:

### **32. POWER TO DISCIPLINE MEMBERS**

32.1 Where the Board is of the opinion that a Member:-

- (a) has refused or neglected to comply with a provision of these rules; or
- (b) has acted in a manner prejudicial to the interests of the Association; or
- (c) has committed an act of misconduct,

then the Board may by resolution refer the matter to the Tribunal Panel for determination under the Association's Disciplinary Policy.

32.2 Where the Board by resolution accepts the determination of the Tribunal Panel to expel a member, the Secretary shall, within 7 days thereof, by notice in writing,

inform the Member of that resolution and of the Member's right of appeal under Rule 33.

32.3 The expulsion of a Member under Rule 32.2 does not take effect until whichever of the following occurs later:

- (a) the fourteenth day after the day on which a notice is served on the member under Rule 32.2;
- (b) if the Member exercises his or her right of appeal under this rule, the conclusion of the special general meeting convened to hear the appeal.

**Reasons:**

- 1. Current Rule 32 of the BTS Constitution, which gives the Board the direct power to reprimand, fine, suspend or expel members, is redundant as these powers have been transferred to the BTS Tribunal Panel, as described in the BTS Disciplinary Policy.
- 2. The proposed change to Rule 32 grants to the Board the power to refer matters to the BTS Tribunal Panel, which is independent of the Board, for its consideration.
- 3. The proposed change to Rule 32 removes the Board from all disciplinary procedures, with the exception being in the event that the BTS Tribunal Panel recommends that a member be expelled from the Association.
- 4. The intent of the proposed change to Rule 32 is to align the BTS Constitution with current practice, as well as to remove anomalies, duplication and contradictions that currently exist between the constitution, relevant BTS policies and Conditions of Play, as well as to eliminate technical issues that may impinge on the decisions and penalties imposed by the BTS Tribunal Panel.

## **Annex C – Details of Special Resolution 3**

That, by special resolution of the members of the association, Section 33 of the BTS Constitution (2016) be deleted and replaced by the following:

### **33. APPEAL AGAINST EXPULSION**

33.1 A Member may appeal against an expulsion under Rule 32 by serving on the Secretary, within 14 days after the service of a notice under Rule 32.2, a requisition in writing demanding the convening of a general meeting for the purpose of hearing the appeal.

33.2 On receipt of a requisition, the Secretary is to immediately notify the Board of the receipt.

33.3 The Board is to cause a general meeting to be held within 21 days after the day on which the requisition is received.

33.4 At a general meeting convened for the purpose of hearing an appeal under this rule:

- (a) no business other than the question of the expulsion is to be transacted; and
- (b) the Board may place before the meeting details of the grounds of the expulsion and the Board's reasons for the expulsion; and
- (c) the expelled Member must be given an opportunity to be heard; and
- (d) the Members of the Association who are present are to vote by secret ballot on the question of whether the expulsion should be lifted or confirmed.

33.5 If at the general meeting a majority of the Members present vote in favour of the lifting of the expulsion:

- (a) the expulsion is lifted; and
- (b) the expelled Member is entitled to continue as a Member of the Association.

33.6 If at the general meeting a majority of the Members present vote in favour of the confirmation of the expulsion:

- (a) the expulsion takes effect; and
- (b) the expelled Member ceases to be a Member of the Association.

**Reasons:**

1. Current Rule 33 (Right of Appeal of Disciplined Member) requires the BTS Secretary to convene a general meeting of the Association whenever an appeal is received from a member subject to a penalty imposed under current Rule 32. In effect, this rule has not been invoked in recent memory and has been replaced by an appeals process described in the BTS Disciplinary Policy.
2. The proposed change to Rule 33, including a name change to “Appeal Against Expulsion”, recommends that in the event that the BTS Tribunal Panel’s determination is that the member should be expelled from the Association then it should be the responsibility of the members of the Association to hear the appeal and to make the final judgment.
3. The purpose of the proposed change to Rule 33 is to align this rule with the proposed change to Rule 32, and to the BTS Disciplinary Policy.

## **Annex D – Details of Special Resolution 4**

That, by special resolution of the members of the association, Section 41 of the BTS Constitution (2016) be deleted and replaced by the following:

### **41. BY-LAWS, CONDITIONS OF PLAY AND POLICIES**

The Board may make, repeal, amend or alter such By-Laws and Policies as considered necessary for the proper conduct of the operations of the Association. Such By-Laws and Policies must be consistent with the Objects contained in Rule 4 of these Rules.

**Reasons:**

1. While current Rule 41 grants to the Board the power to make changes to BTS By-Laws at any time it does not make any reference to either BTS policies or Conditions of Play.
2. Rule 41 recognises that By-Laws are necessary implements by which the Board is able to ensure that it can adapt quickly to changing circumstances while still functioning within the broad framework of the constitution.
3. BTS policies and Conditions of Play, as with By-Laws, require regular review to ensure that they remain relevant to current practice and need. They are subservient to the constitution which enables them to be amended at any time.
4. The proposed change to Rule 41 is recommended to ensure removal of any doubt as to the powers of the Board to make changes to policies and Conditions of Play in the same manner in which it is able to do with By-Laws currently.
