

It is with great pleasure that I present my eighth President's Report to you. A number of innovations introduced by the Board for 2022-23 have proved to be actions that have resulted in benefits to our affiliated clubs, and it is hoped that the initiatives put in place will continue to accrue positive outcomes in future years.

The introduction of a fixed once-only affiliation fee has achieved the aims that were considered to flow from this major change in the annual fees paid by clubs to the Association, the most important of which has been the ability of clubs to introduce their social/barefoot bowlers to pennant competition, as a precursor to becoming full playing members. A total of 81 social/barefooters participated in the "Social 5 game" pennant initiative, with a number transferring to a full playing membership. This has resulted in an actual increase in total playing numbers for the first time in many years, and it is hoped that this trend will continue in future years. Clubs' willingness to make use of the "Social 5 game" option has encouraged the Board to continue with the initiative into the future, as it provides potential pennant players with the ability to a "taster' pennant experience at minimal cost.

No club or association should build on its surplus funds year on year without there being some plan for their use, and this has been the case with Bowls Tasmania South, with \$22,500 distributed to clubs during the season to support successful grant applications. The Board's decision to provide clubs with access to two separate grants, funded from the Association's reserves, one with a goal to increase player participation and the other the creation of club-based junior programs, has encouraged clubs to be proactive in the development of programs and activities to gain access to the grant monies, with every grant submission received being successful.

Actions have been taken by the Board to restructure tribunal and appeals procedures to ensure that the Board has no role in either of these important functions. It is inappropriate for the rules setting body, in this case the Board of Bowls Tasmania South, to also adjudicate on matters relating to those same rules. During the season, matters requiring a judiciary procedure were referred to an independent panel and, where there was an appeal against the decision of the tribunal panel, an independent appeals panel was formed. In all cases, the independent tribunal panels and appeals committees conducted their deliberations in a professional manner devoid of any interference from the Board. I thank all members who have made themselves available to participate in these important functions on behalf of the Association.

The bowls season is becoming increasingly congested with pennant competitions, BTS championship events, Bowls Tasmania Gala weeks, and Statewide Challenge events crowding the calendar. Allied to this is an increasing push back from players about the

length of the season, and a growing desire for changes to the structure of BTS pennant competitions. At the BTS Delegates meeting in March, club delegates gave in-principle support for the establishment of a Pennant Review Working Group, consisting of representatives from a number of clubs, to investigate alternatives to the current pennant setup in the South. This will be a club-led process with the Board remaining at arms-length from the discussions. It is hoped that the Board will be swamped with names when, in the near future, nominations are called for the working group.

Annual costs associated with the conduct of bowls competitions in Southern Tasmania are ever increasing and the Board is mindful of keeping the financial impost to clubs as low as possible, which means that the Association's expenditure budget is where savings are to be found. There are items which are mandatory expenditures and cannot be adjusted, so it is the discretionary expenditures where paring back occurs. While these are hard decisions to make, they are necessary to rein in costs while still providing full service.

Funding constraints are not limited to Bowls South, with Bowls Tasmania investigating areas of its annual budget that can be either contained or reduced while still maintaining a full program of events. One program under serious scrutiny is the Statewide Challenge series currently played over three rounds for Open and Senior Men's and Women's sides, with clubs in each region hosting one round each season. There is a proposal to centralise the series with all three rounds being played in the Launceston area each season. The BTS Board does not support the proposal and has vigorously opposed it at Regional Consultative Committee meetings because it is not an equitable proposition, and does not take into consideration the financial benefits gained by the host clubs. The final decision whether centralisation occurs rests with the Bowls Tasmania Board, which puts in doubt where rounds of the Statewide Challenge series will be played during the 2023-24 season.

Changes to the BTS Constitution, specifically the quorum for Board meetings, have enabled the Board to function more effectively during 2022-23, albeit without a Vice President or two ordinary Board members (male). I commend all members of the Board for the quality of service that they are providing to the Association. I am particularly thankful to the members new to the Board this season, Barbara Rankin and Crystal Brooks, both of whom have brought new ideas to our discussions. Barbara has been a primary contact for clubs seeking advice regarding grant application procedures, and Crystal has had the responsibility of managing the BTS Facebook page. I am pleased that neither Barbara nor Crystal found their first year of membership of the Board too daunting and have nominated to continue on the Board in 2023-24.

Secretary Paul Matthews and Treasurer Deb Jeffrey conducted an excellent Governance Seminar for club executives during the latter part of the year, focusing on financial matters, as well as the need to ensure that rules in the club's constitution contain sufficient flexibility to enable the club's Board to function effectively. Deb and Paul have settled into their respective roles most admirably. Both have excellent skills and knowledge appropriate to their positions, enabling both to provide high quality service to the Association, as well as assisting the Board to work efficiently on behalf of the members. Deb's financial reports to the Board are always comprehensive and factual, giving clear evidence of the Association's current financial position, while Paul's

administrative skills are evidenced in the quality of his communications to the Board, and the southern bowls community, generally. I thank them both, most heartedly, for their diligent efforts throughout the year.

Chair of the officiating Panel, Michael Andersch, and his panel members have ensured that all officiating needs for BTS events, as well as Bowls Tasmania events held in the south, have had enough officials to cater to the needs of players during competition. Michael has been working with Leonie Price to conduct officiating workshops in the North and North-West of the state during Bowls Tasmania Gala Week events held in those regions to upskill officials in those regions, and to increase the efficiency of bowls officials statewide. I commend Michael for the power of work that he gets through, and thank him for his commitment to improving the quality of our officials.

Ross Bannister, Chair of the Match Committee, continues to provide good service to the Association, and, with assistance from his committee members, is responsible for setting up pennant rosters, the scheduling of BTS events, and the allocation of events to clubs, as well as adjudicating on matters relating to Conditions of Play. As well as this significant role, Ross also heads up the Coaching panel, and conducts officiating and coaching courses for new candidates, and for coaches and officials needing to re-accredit. In each of these roles Ross works hard to provide quality service to the Association and its members, and I congratulate him for the work that he does for us.

Executive Assistant and Statistician, Paul Hoddy, has the task of setting up the BowlsLink Results Portal for Pennant competitions, and for BTS championship events. Paul is also a member of the Bowls Australia committee that has responsibility for the development of BowlsLink, and the work that he does for the Association provides opportunities to test aspects of BowlsLink, enabling the identification of the "gremlins" and glitches that need to be resolved to ensure that the program operates efficiently for all users. The main thrust during the season has been the use of BowlsLink as the entry point for BTS championship events, and for conducting the draw once entries have closed. I am in awe of Paul's efforts on behalf of the Association, especially as he does so while also in fulltime employment.

I congratulate all BTS Pennant winners, in Saturday Pennant: Kingborough (Premier Division), Howrah (Division 1), Rosny Park (Division 2), Kingborough (Division 3), Cygnet (Division 4), Claremont (Division 5), and Franklin (Division 6); Women's Thursday Pennant: Howrah (Division 1), Cremorne (Division 2), North Hobart (Division 3), and Glenorchy Rodman (Division 4; and Men's Wednesday Pennant: Kingborough (Division 1), Royal Hobart (Division 2), Claremont (Division 3), and Kingborough (Division 4).

Southern clubs' involvement in Bowls Tasmania's Saturday Pennant State Finals, held this season in Burnie on the North-West Coast was, overall, not too successful, except for the one bright light, Franklin, winners of the Division 6 State Pennant Final. It was a very successful season for Franklin, also receiving the Fitzgerald trophy for Bowls South's Club of the Year at the recent Annual Presentation Night, a most worthy achievement for a small go-ahead club, and great encouragement to the club's management in their efforts to increase their playing numbers and pennant involvement.

The Royal Hobart Bowls Club is another to highlight, having, in my time as BTS President, moved from an all-cream uniform to colour, introduced bowls stickers for their members' use, and entering a side in Women's Thursday Pennant Division 4 for first time this season. The ladies performed creditably, finishing second in their section (Division 4 Blue), winning the Elimination Final, but losing the Preliminary Final to Claremont to finish third in their initial year. Congratulations to Royal Hobart's women on a very successful start, and to Paul McCann and other male members of Royal Hobart for their support and encouragement given to their female club members.

Congratulations to southern bowlers who were successful in the various Bowls Tasmania events conducted during the season: Miley Sutton and Jayla Triffitt in winning the State Junior Girls Pairs, Luke Turner and Jack Ellis, members of a composite team that won the State Men's Open Fours, Noel Buckingham, the State Bowling Arm Singles Champion, Carol Bannister, Robyn Leggett, Jac Phillips and Jan Hobbs, State Senior Fours Champions, Ailsa Milburn and Christine McGrath, State Senior Women's Pairs Champions, Shane Young, Chris Norris, Roger Dale, and Steve Graf, State Senior Men's Fours Champions, Mark Quinane and Michael Gallen, State Men's B Grade Pairs Champions, and Jacob Sherrin-Wall, State Bowlers with a Physical Disability Singles Champion.

Congratulations to Joy Voss (Women's Open), Rose Williams (Women's B Grade), Grant Wakefield (Men's Open) and Shane Winter (Men's B Grade) for achieving the personal accolade of being named BTS Bowler of the Year for 2022-23. A strong commitment to participating in all BTS Championship events is partly due to the success of our Bowlers of the Year, but ability, good support from other members in team events, and success across a number of events is the key to achieving this personal accolade.

Attracting sponsors to support BTS pennant competitions and other programs is very difficult, and disheartening, and I accept responsibility for a lack of effort to pursue new sponsorship opportunities. Positive steps have been taken in recent times to seek support through Clubs Tasmania to identify possible new corporate arrangements. Notwithstanding this, the Board is most grateful to the support provided by our valued sponsors, Doug Cole (Junior program), Derwent Eye Specialists (Saturday Premier Division) and J Carroll Club Promotions (Pennant scorecards), all of which has helped to reduce annual affiliation fees paid to the Association by clubs.

It is an honour to provide service to the clubs and individual members of Bowls Tasmania South, and I am pleased to be able to continue in my role as president of Bowls Tasmania South for another year. There is always another major project to see through to fruition, this time the emergence of the potential for a vigorous examination of pennant structures in southern Tasmania led by a committee representing the affiliated clubs. I look forward with keen anticipation the outcomes of the committee's deliberations and, more importantly, the recommendations the committee makes for consideration by the southern bowls community, as well as the opportunity to work with clubs and the Board to introduce any changes that emanate from the committee's findings.

I'm pleased to present the following report for 2023.

As you are aware, BTS announced the Junior Development & Club Incentive Program for 2022-23. At the same time, BTS also introduced the 5-game member incentive, allowing players to play up to 5 games in pennant before deciding if they wanted to continue as a full playing member.

As a result, BTS received requests from 17 clubs covering both Junior Development and Club Incentive Programs, subsequently paying out a total of \$22,500 (ex GST). We also saw several new names under the 5-game area and ended up with an increase of 25 new pennant players.

BTS finished the financial year with an operating profit of \$607, which is a \$2,787 improvement on last year. However, our net profit ended up as a loss of \$-25,867.94 which is due to the above-mentioned injection of funds into 17 clubs for the incentive programs, and the purchase of new SWC uniforms.

Bowls Tasmania flat fee revenue continues for the 2023-24 season. With the fees set, BTS will pay \$102, 097, North \$77,579, and North-West \$75,139 including GST.

BTS has also continued with the flat fee revenue for 2023-24. Each club will receive their advanced affiliation fee notice, which will help clubs with their annual budget. As previously advised, this calculation is based on your BowlsLink players registration as at the census date, 28th February each year. BTS will provide each club with a tax invoice early September, and payment will be due 1st October 2023.

We have attempted to keep affiliation fees to a similar overall amount to last year. It is important to know, like most clubs, sponsorship is diminishing, but if new sponsorship becomes available in the future, this will contribute towards the players and clubs.

In 2023-24 BTS will continue focusing on junior development and supporting clubs in general.

This season was the first time that the BTS championship draws were done though the bowls link system. There were some teething problems with players entering their names or teams and the way the bowls link system did some draws but in the end we got there. One of the problems we found is that club members played each other in the first round or in sectional play, were before this did not happen.

On behalf of the committee, I would also like to thank all the clubs that held southern championship events, as we tried to spread the championships around different bowls clubs this season again but it's very difficult with some clubs not willing to hold Bowls South championships. This season several BTS championships were played on the new synthetic greens that was installed.

Congratulations to the winners of all of our championships as well as those pennant teams that won finals or gained promotion.

Another season southern bowls club had pennant points taken of them this season and other clubs have had warnings when they have breached the BTS conditions of play for pennant. This seems to happen every season The Match Committee and Bowls South can only apply the rules that are in the Bowls South Condition of play and cannot deviate from them.

Several southern clubs put in complaints this season about green conditions and the speed of the greens. It clearly stated in the bowls south condition of play what side captains are supposed to do, it's up to each club to make sure their side captains know the procedures. And if the proper procedures are not followed, the match committee has no option but to reject the complaint even if it is valid.

#### COACHES PANEL REPORT

Last winter from May through to August on the last Sunday of the month coaching sessions were once again scheduled for the Howrah indoor centre On behalf of the coaches that assisted with the training, I would like to thank the Howrah Bowls Club for opening their club on these Sundays and making it available for the coaching sessions and Bowls South for paying the hire fee to allowing bowlers from other bowls clubs to come and use the indoor centre for free.

This winter's coaching sessions will be held again from May to August in 2023 on the last Sunday of the months for this winter at the Howrah indoor centre.

The southern junior also had training sessions over the summer months on Friday nights conducted by the southern junior coach John Nichols.

I have said this every year now, for some reason most lawn bowlers don't want coaching, may be it shows up something we can't do on the grass green or the synthetics, were in any other sport coaching is a big part of the game may be it times for change.

Our southern coach's committee members are more than happy to travel to any bowls club that needs help in running or organising bowls coaching sessions. If any clubs would like to organise a coaching day all they have to do is contact the southern coaches' panel through Bowls South.

Most of our southern coach's certification has or will expire this year and it is very simple to be requalified as a club coach by having your bowls club write an current competent letter saying that you have been actively coaching at your bowls club, fill out an application form, supplying a photo copy of your working with vulnerable people card and watch the coaches den videos on Bowls Australia web site. The recertification fee is \$25.00 to cover the cost of a new certification card.

There have been coachers certification courses run in the south this season with bowlers gaining their coachers certifications so if your bowls club does not have a qualified bowls coachers, you need to talk to your clubs committee and arrange to get qualified.

Every bowls club in the south should have at least two female and two male coaches in their club. If you would like to become a coach or know of somebody that would be a good bowls coach please let me know and we can organise your registration through Bowls Tasmania for the next Southern Club Coaches course.

#### OFFICIATING PANEL REPORT

Wayne Cobbing and Janet Rutherford joined myself, Leonie Price and Helen Ducker and became more active in our Officiating Panel management and events over the year.

Every three years, the panel and our umpires/markers get a bit more of a rest with the South only hosting its share of the Statewide Challenge, Seniors Championships and Bowling Arm Round Robin, alongside the BTS Championships. Next January, Gala Week comes back to the South and the usual rallying of the troops will see us reach out to more officials to assist cover events.

This year we have successfully rotated through available officials to share the workload and we've taken time to match personalities and home clubs of our officials to the events they look after. Champion of Champions particularly, with 8-9 officials across three nights of bowls in the same week clubs and players are preparing and practising for pennant finals, was the greater of our challenges, but one that was overcome.

The Panel continues to advocate and encourage all officials to hold Working with Vulnerable People Certification. Particularly with the requirements for juniors and disability bowls events, we can only allocate accredited officials with a WWVP card to these events. We've heard the argument "I only umpire for our Club during pennants and we don't have any juniors, so I don't need it". However the certification goes beyond just juniors/children. Our elderly population of bowlers would have a sizable number of potentially Vulnerable People and the act of officiating in a game of bowls may involve managing conflict and resolving difference of opinion.

It is pleasing that our International Technical Officials and National Umpires have become more involved in events held outside the South. With the Panel's former Chair, Leonie Price, joining the Bowls Tasmania board and taking the umpiring portfolio, the pathway to share officiating learnings and personnel has been made easier. In both northern Gala Weeks, up to 7 of our BTS officials assisted the locals in both umpiring and marking across a range of events.

Similarly, in Burnie during March, we hosted an Officials Forum and this was attended by over 15 NW officials. A strong relationship has developed with BowlsNW which has appointed a Director of Umpiring in David Gewin from Burnie BC. David is keen to see best-practice techniques communicated, trained and adopted across the NW Coast. To this end, BowlsNW is funding up to 28 bowlers in their affiliated clubs to accredit as umpires and called upon our two ITOs (who are also Presenters and Assessors) join the panel taking the 1½ day course to be scheduled ahead of next season.

This season wrapped up with Officials supporting Bowls South Pennant Finals across the three playing days and five different venues. I thank all that have responded to the call to assist keep watch over these finals.

Heading into the off season the Officiating Panel will discuss the feedback it has received over the season to frame its input to the review of the next edition of the Conditions of Play. This, alongside the new CM-version 4 Law Book gives us ample items for discussion at the Officials Forum in October and November this year.

In the off season, a review of expiry dates for Officials accreditation will ensue, and hence we will be contacting them, foreshadowing the upcoming 2023-24 course dates to assist ensure our Panel and Clubs achieve some continuation of service from our current Officials, even if it's just for the purpose of club events and pennant. Likewise, Clubs should look at the own list of Officials and ensure they have sufficient coverage in terms of the number of divisions, gendered competitions, hosting of BTS/BT events and give consideration to ages of your current volunteer officials.

#### **Annual Report and Financial Report**

President, Peter Kirby spoke to his report as published within the Annual Report and expanded on some points, making particular mention of the difficult year experienced by the Board caused by a number of resignations due to personal and health reasons.

The vacant Treasurer position was filled with the recruitment of Deb Jeffrey, who has performed her duties to a very high standard. The resignation of long-serving BTS Secretary, Rob McGuire, due to his recruitment to the BTAS CEO position, created another mid-term vacancy which was filled by the recruitment of Paul Matthews, who has brought a range of specific skills and attributes to the position.

Peter also made mention of the gap in corporate memory caused by Rob's departure, which has been rectified by the documentation of Board functions and processes through specific policies and protocols. The Board is working progressively towards the delegation of operational matters to committees with the Board focusing on the provision of strategic direction through policies to guide the operation of committees. Moved Peter Kirby, seconded Dale Freeman: "That the annual report be received."

The Treasurer's report was also presented by President Peter Kirby, along with the audited financial statements as published within the Annual Report. In speaking to the 2022-23 Budget Peter made special mention of two programs to be funded from reserve funds to support clubs' recruitment of adult members, and to support clubs' junior programs, both of which are aimed to increase participation in pennant. Funding for these two programs will reduce reserve funds by an amount of \$40,000, approximately. Moved Peter Kirby, seconded Ross Bannister: "That the audited financial statements be adopted."

  - (e) is disqualified from holding office, due to non-compliance to these rules or conduct prejudicial to the interests and policies of the Association;
  - (f) is convicted of an indictable offence; or
  - (g) is absent without the consent of the Board from three (3) consecutive meetings of the Board.
